Annex 1: Terms and Conditions

With submitting a case report to Bentley, the Clinic agrees on the following:

Case Report Conditions (mandatory)

Herewith I agree on the conditions on the provision of the case report.

I further confirm that the clinic (employer) has agreed on the submission of this case report and its use and provide Bentley with a copy of the clinic's approval (applicable for: D, FR, I, GB, AU, SUI)

The case report shall fulfil the following parameters:

- A Bentley product is of major importance within description of the case. Other products should be mention
 as well so that the report has a complete and consistent structure.
- Give it a title that refers to the topic and states its name, function and the clinic where you work.
- The case report must be written in British English.
- State references, if necessary.
- Maximum of 500 words (excluding references)
- A4
- 3-5 informative images to better illustrate the case.
- Case report (including images) must be fully anonymised concerning patient data.
- The structure of the case report shall be as follows:
 - 1. Patient history
 - 2. Treatment
 - 3. Follow-up
 - 4. Conclusion

(Note: case series and follow-up >6 month increase the score)

The submitter confirms that he/she is entitled to provide the case report to Bentley and that the case report does not violate third party rights. Bentley herewith confirms that it will not supplement, change, or otherwise revise the case report provided and/or instruct the submitter to revise the same.

Bentley will use the case report for internal regulatory purposes (e.g., post-market surveillance). The submitter complies with all applicable laws and procures, and obtains all necessary permits / consents required by it for the performance and provision of the case report.





The submitter hereby **transfers its rights** with respect to the case report **to Bentley**. If and to the extent that such a transfer is not legally possible, the submitter hereby grants to Bentley the exclusive, irrevocable, transferable, sub-licensable, unrestricted, and worldwide rights to utilize the case report as stated herein and otherwise agreed with Bentley

Bentley and the submitter confirm that these conditions have been agreed without reference to and independent from any sales transactions and procurement decisions. Bentley shall be entitled to disclose the cooperation with the submitter if required for compliance reasons.

The agreement and use of the case report as agreed is conditioned upon the receipt of the approval of the same by the submitter's employee / clinic (if applicable).

This agreement is subject to German law. If the physician is not subject to the general jurisdiction of the courts in Germany, the court at the registered office of Bentley shall have jurisdiction.

Case Report Conditions (optional)

In addition to the general conditions, I herewith agree with the participation in the case report contest and being contacted for such purpose as explained below.

- Bentley offers the submitter the opportunity to participate in a case report contest whereby all case reports
 provided to Bentley and released by the submitter will be provided to the EVC (https://vascular-course.com/)
 on an anonymized basis. The submitter agrees to the disclosure of its data and case report to
 the EVC organization.
- The EVC board will evaluate the case reports and choose the most outrageous out of all case reports submitted and will inform Bentley respectively.
- Bentley will then disclose to EVC the name of the submitter winning the contest who will then be informed by
 EVC in its own responsibility.
- There is no legal entitlement to the prize.
- Deadline for submission is the 31st of December of every respective year.





The Award

- The winner will be invited to the next annual EVC course. Exact time and place of such course will be communicated to the winner as soon as possible.
- The award covers travel expenses, accommodation and EVC participant registration, based on the conditions of EVC.
- The winner has the possibility to present and discuss the submitted case with an EVC faculty member in front
 of an audience within the EVC program.

Marketing Conditions (optional)
